

RESOLUTION NO. 2023-337

A RESOLUTION AUTHORIZING THE USAGE OF  
CONTRACTS WITH CUMBERLAND COUNTY COOPERATIVE  
PRICING SYSTEM VENDORS, IDENTIFIER #181-CCCCPS FOR  
THE 2023 CALENDAR YEAR.

**WHEREAS**, the City of Vineland is a member of the Cumberland County Cooperative Pricing System, Identifier #181-CCCCPS, pursuant to N.J.S.A. 40A:10, 11& N.J.A.C. 5:34-7.3, 7.4, 7.12 and Resolution No. 96-534 adopted on August 13, 1996 by the City of Vineland's City Council; and

**WHEREAS**, the City of Vineland has the need, on a timely basis, to purchase goods or services by utilizing the Cumberland County Cooperative Pricing System Contracts & Vendors; and

**WHEREAS**, the City of Vineland may enter into contractual agreements with the Cumberland County Cooperative Pricing System Vendors through this resolution and properly executed contracts/purchase orders, which shall be subject to all the conditions applicable to the current New Jersey Local Public State Contracts Law; and

**NOW THEREFORE, BE IT RESOLVED**, that the City Council of the City of Vineland, New Jersey authorizes the City Purchasing Agent to purchase certain goods or services from the approved Cumberland County Cooperative Pricing System, Identifier #181-CCCCPS, pursuant to all conditions of the Cumberland County Cooperative Pricing System individual Contracts; and

**BE IT FURTHER RESOLVED**, that the Cumberland County Cooperative Pricing System, Identifier #181-CCCCPS Contract vendors and their corresponding numbers may change during the timeframe indicated below and that the City Purchasing Agent is hereby authorized to make the necessary adjustments to the vendor list as may be required for the City to continue its routine procurement practices throughout the indicated timeframe; and

**BE IT FURTHER RESOLVED**, that the City Council of the City of Vineland, pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds and that no contract amount shall be chargeable or certified until such times as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds shall be made by the City's Chief Financial Officer; and

**BE IT FURTHER RESOLVED** that the duration of the contracts between the City of Vineland and the Cumberland County Cooperative Pricing System, Identifier #181-CCCCPS Contract Vendors shall be for the period of July 11, 2023 through December 31, 2023 or until the expiration of the referenced vendors' Cumberland County Cooperative Pricing System, Identifier #181-CCCCPS Contract, whichever shall occur first.
