WHEREAS, the City Council of the City of Vineland, on July 12, 2022 adopted Resolution No. 2022-282, Authorizing a Professional Engineering Services Contract with Adams, Rehmann and Heggan Associates, Inc., Hammonton, NJ, for the Memorial Park Dam Repairs, in an amount not to exceed \$47,500.00; and

WHEREAS, there exists a need to amend and supplement the Professional Services contract awarded to Adams, Rehmann and Heggan Associates, Inc., for the above professional engineering services as authorized by Resolution No. 2022-282; said change order is necessary because since starting the dam rehabilitation project, several changes have occurred which resulted in a change in scope as follows:

- 1. A non-vegetated surface walkway was added along the upstream embankment, serving a dual role as pedestrian passage and limiting vegetation growth under the guide rail.
- 2. In addition, a catwalk was added to provide easy access to the flashboards during storm events.
- 3. Finally, the existing spillway flashboards will be replaced with aluminum stop logs set in a stainless steel guide; and

WHEREAS, the Chief Financial Officer has certified that funds for the amendment requested herein are available; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland as follows:

1. THAT said amendatory supplemental change order #1 to Contract No. C22-0052,

The change order requested in the amount of \$9,900.00 is necessary because since starting the dam rehabilitation project, several changes have occurred which resulted in a change in scope as follows:

# MEMORANDUM

Re:	Memorial Park Dam Rehabilitation: Change Order Request ARH #6700002

The original proposal response for Memorial Park Dam had included upstream and downstream embankment protection and concrete rehabilitation. Since starting the dam rehabilitation design project, several changes have occurred which resulted in a change in scope. Based on discussions with the City, additional improvements have been added, necessitating communication with vendors, additional details, calculations specifications and drawings:

- 1. A Nonvegetated Surface walkway was added along the upstream embankment, serving a dual role as pedestrian passage and limiting growth of vegetation under the guide rail. At project outset, ARH was instructed not to include any type of walkway or access.
- In addition, a catwalk was added to provide easy access to the flashboards during storm events. The catwalk will also enable public works personnel to clear any vegetation or debris from the weir crest.
- 3. Finally, the existing spillway flashboards are in fair condition but will be replaced as part of this work by aluminum stop logs set in a stainless steel guide.

As a result of these changes, we respectfully request a change order in the amount of \$9,900 for the tasks as described above.
