A RESOLUTION PROVIDING FOR THE INSERTION IN THE CALENDAR YEAR 2023 BUDGET OF THE CITY OF VINELAND A SPECIAL ITEM OF REVENUE MADE AVAILABLE BY REVENUE REALIZED FROM A COUNTY OF CUMBERLAND, MUNICIPAL ALLIANCE GRANT TO PREVENT ALCOHOLISM AND DRUG ABUSE, IN THE AMOUNT OF \$23,231.00 AND AN APPROPRIATION IN SAID BUDGET FOR LIKE SUM AND PURPOSE.

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for equal amount;

NOW, THEREFORE, BE IT RESOLVED, as follows:

SECTION 1. THAT the Council of the City of Vineland hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the Calendar Year 2023 in the sum of.....\$23,231.00

which item is now available as a revenue from a County of Cumberland, Municipal Alliance Grant to Prevent Alcoholism and Drug Abuse pursuant to the provisions of statute;

SECTION 2. THAT a like sum of .....\$23,231.00

County of Cumberland, Municipal Alliance to Prevent Alcoholism and Drug Abuse 2023-2024

SECTION 3. THAT the sum of.....\$ 3,474.00 representing the amount required for the municipality's share of the aforementioned grant appears in the Calendar Year 2023 Budget, and is hereby appropriated under the caption of Operating Expense under Various Departments in the City of Vineland.


The undersigned accepts this document and the Program Guidelines found at <http://gcada.nj.gov/alliance/forms/> as well as County Fiscal Reporting Requirements previously set forth to be Terms and Conditions for grant participation in the Alliance to Prevent Alcoholism and Drug Abuse.

This Letter of Agreement will remain valid for one (1) year from July 1, 2023 through June 30, 2024, contingent on full compliance with all Terms and Conditions.

If through any cause within its control, **CITY OF VINELAND**(hereinafter the **GRANTEE**) shall fail to fulfill in a timely and professional manner the obligations under this Agreement, or if the **GRANTEE** should violate any of its covenants, provision or stipulations, the **COUNTY OF CUMBERLAND** (hereinafter the **COUNTY**) will thereupon have the right to terminate this Agreement by written notice to the **GRANTEE** and specifying the effective date thereof, at least thirty (30) days prior to the termination date.


Funds issued by the **COUNTY** to the **GRANTEE** under this Letter of Agreement shall not exceed \$23,231.00


