RESOLUTION NO. 2023- 461

RESOLUTION AUTHORIZING THE ISSUANCE OF A RENEWAL OF A CLASS V ANNUAL CANNABIS RETAIL LICENSE TO COLUMBIA CARE NEW JERSEY LLC, 1062 NORTH DELSEA DRIVE, VINELAND, NEW JERSEY CONDITIONED UPON THE ISSUANCE OF A RENEWAL LICENSE BY THE STATE OF NEW JERSEY CANNABIS REGULATORY COMMISSION AND THE EXECUTION OF A HOST COMMUNITY AGREEMENT.

WHEREAS, City Council has authorized the issuance of two (2) Class V Cannabis Retail Licenses within the City; and

WHEREAS, Columbia Care New Jersey LLC was the holder of a Medical Marijuana license for the sale to the public of medical marijuana at a facility located at 1062 North Delsea Drive, Vineland, New Jersey, specifically State License No. RE000010 which was expanded to the sale of adult use cannabis and cannabis products in accordance with the Cannabis Regulatory Commission rules and regulations, N.J.A.C. 17:30-7.1; and

WHEREAS, the annual license for the adult use retail facility was expiring, but was extended by the Business Administrator in accordance with the Code of the City of Vineland pending the receipt of an annual license renewal application which was received and reviewed by the City of Vineland Cannabis Advisory Committee (CAC); and

WHEREAS, after review of the proposal, the CAC recommended the renewal of the adult use Class V cultivation license located at 1062 North Delsea Drive, Vineland, New Jersey, retroactive to April 15, 2023 for a period of one year subject to the execution of a Host Community Agreement containing all of the terms and conditions set forth in the proposal submitted by Columbia Care New Jersey LLC dated June 29, 2023; and

WHEREAS, Council finds it to be in the best interest of the City to renew the adult use Class V cannabis retail license for Columbia Care New Jersey LLC for their location at 1062 North Delsea Drive, Vineland, New Jersey for a period of one (1) year retroactive to April 15, 2023 and expiring April 14, 2024 subject to the execution of a Host Community Agreement and the issuance of a state license.

NOW THEREFORE BE IT RESOLVED by the Council of the City of Vineland that a Class V Municipal Cannabis Retail License renewal be issued to Columbia Care New Jersey LLC for their facility located at 1062 North Delsea Drive for a period of one (1) year retroactive to April 15, 2023 and expiring April 14, 2024 subject to the execution of a Host Community Agreement containing all of the terms in the proposal submitted dated June 29, 2023 and further provided the state issued license remains in effect.
