A RESOLUTION AMENDING RESOLUTION NO. 2022-464  
TO CORRECT A TYPOGRAPHICAL ERROR THEREIN.

WHEREAS, on November 7, 2022, the City Council of the City of Vineland, adopted Resolution No. 2022-464, entitled “A RESOLUTION TO AMEND AND SUPPLEMENT RESOLUTION NO. 2021-641, ENTITLED “A RESOLUTION AUTHORIZING AN OPEN-END CONTRACT TO A STATE CONTRACT VENDOR, MORTON SALT, INC., CHICAGO, IL, FOR THE SUPPLY AND DELIVERY OF SODIUM CHLORIDE (ROCK SALT)””; and

WHEREAS, the original contract was awarded for Sodium Chloride (Rock Salt) for a period of three (3) years from date of award through June 30, 2024, in an amount not to exceed \$70.48 per ton; and

WHEREAS, Resolution No. 2022-464 was adopted to provide for the increased pricing amount of \$89.77 valid from July 1, 2022 to June 30, 2023, which is an incorrect date and should refer to July 1, 2022 to **June 30, 2024** as the valid period; and

WHEREAS, it is in the best interest of the City to amend the Resolution 2022-464 to reflect the correct contract period;

NOW THEREFORE BE IT RESOLVED by the Council of the City of Vineland that Resolution 2022-464 is hereby amended to reflect the correct contract period of July 1, 2022 to June 30, 2024.
