## ORDINANCE NO. 2023-64

## ORDINANCE DESIGNATING NO PARKING RESTRICTIONS ALONG A PORTION OF STATE STREET AND AMENDING ORDINANCE NO. 1294 AND REPEALING ORDINANCE NO. 99-14.

WHEREAS, the City Council of the City of Vineland on April 27, 1982 adopted Ordinance No. 1294, entitled "An Ordinance Amending Ordinance No. 939 and Providing for No Parking Restrictions on State Street in the City of Vineland, which changed the following "No Parking" restrictions to:

WHEREAS, the City Council of the City of Vineland on March 23, 1999 adopted Ordinance No. 99-14 which provided for "No Parking" restrictions along a portion of State Street as follows:

Name of Street:	Side:	Location:
State Street ( <b>Ord. No. 99-14</b> )	West	From a point 391 feet south of the southerly curbline (projected of Almond Street and extending 130 feet southerly thereof.

WHEREAS, the City Engineer has recently reviewed on-street parking for State Street between Landis Avenue and Chestnut Avenue and has concluded that the street is not wide enough to accommodate parking on both sides of the street with two-way traffic; and

WHEREAS, the City Engineer has recommended that on-street parking should only be permitted on the west side of State Street between Landis Avenue and Chestnut Avenue with an exception of one area on the east side of State Street;

WHEREAS, it is in the best interest of the City of Vineland to provide for new parking restrictions along a portion of State Street and repeal Ordinance No. 99-14 and amend Ordinance 1294 in accordance with the recommendations of the City Engineer;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that:

**SECTION 1:** No person shall park a vehicle at anytime upon any of the following described streets or part of streets:

Name of Street	Side	Ordinance No.	Location
State Street	East	NEW	From the northerly curbline of Chestnut Avenue and extending to a point 196 feet south of the southerly curbline of Almond Street

**SECTION 2:** Ordinance No. 1294 shall be amended as follows:

No person shall park a vehicle at anytime upon any of the following described streets or part of streets:

Name of Street:	Side:	Location:	
State Street (Ord. No. 1294)	East	From Landis Avenue to Almond Street	

**SECTION 3:** Ordinance No. 1294 shall also be amended to **repeal** the following section:

Name of Street:	Side:	Location:
State Street	West	From the prolongation of Almond Street to a point 280 feet
(Ord. No. 1294)	REPEAL	southerly therefrom.

**SECTION 4:** The balance of Ordinance No. 1294 not amended hereby shall remain in full force and effect as follows:

**SECTION 5:** Ordinance No. 99-14 is hereby **repealed** in its entirety.

**SECTION 6:** Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.

**SECTION 7:** All other ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 8:** This Ordinance shall take effect upon passage and publication as provided by law and upon approval by the Commissioner of Transportation of the State of New Jersey.

**SECTION 9:** Any person who violates this Ordinance shall be subject to fines and penalties as set forth in the Code of the City of Vineland at §694-28.

RE: State Street Request to Amend and Repeal No Parking Ordinances

Bob Dickenson, Business Administrator:

Our office originally sent this request to your office on August 3, 2023, but then we had it pulled from Council due to the current senior housing construction. After review of the Newcomb Senior Housing site plan, revisions were made to the State Street No Parking request from last months letter. The only change was for a section of on-street parking to also be permitted on the east side of State Street, just south of Almond Street.

I have received concerns from residents regarding speeding along State Street between Chestnut Avenue and Landis Avenue. Residents believe that speeding has increased since the development of the new Senior housing near Almond Street. Our office has since worked with Public Works Traffic Safety to complete a Work Order to install new and/or upgrade the existing speed limit signs. Additionally, our upcoming linestriping project this Fall includes State Street to be restriped to calm the traffic.

With that in mind, the existing double yellow centerline is located in the center of the road with on-street parking on the east and west side of the road in different limits. The roadway is not wide enough to accommodate parking on both sides of the street with two-way traffic. The roadway is 30 feet wide, which is only enough room to permit parking on one side of the road.

This section of State Street will be restriped to shift the centerline to the east so that the shoulder width on the west side of the road will be wide enough for on-street parked vehicles. Striping will result in two 10-foot travel lanes with an 8-foot shoulder on the west side of the road and a 2-foot shoulder on the east side. On-street parking will only be permitted on the west side of the road, except for parking on the east side of the road in one area. On-street parking will be permitted on the east side of State Street just south of Almond Street. The Newcomb Senior Housing site plan includes eight on street-parking stalls.

A new Work Order will be sent to Public Works to update the No Parking signs on State Street to correspond with the revised ordinance. Also, a letter has been sent to all residents/property owners along this section of State Street. The letter notified them of the upcoming linestriping project and the revised parking restriction.







As a result, please prepare an Ordinance to repeal the following existing No Parking Ordinances established on State Street as follows:

State Street	West	§99-14 (REPEAL)	From a point 391 feet south of the southerly curbline (projected) of Almond Street and extending 130 feet southerly thereof
