WHEREAS, the Director of Licenses and Inspections has requested that an amendment be made to contract awarded to Perryman’s Excavating Inc., Milmay, NJ for the Demolition of Structures Located at 1100 Elm Road (Block 5502, Lot 60) as authorized by Resolution No. 2023-372: said amendment is necessary to provide for 2 additional dumpsters needed for cleanup outside of the demolition work area; and

WHEREAS, the City of Vineland desires to comply with said requirements of N.J.A.C. 5:30-11.1, et seq., and to that end herewith files with the governing body a report stating the facts involved and indicating that the proposed change order may be allowed under these regulations; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the amendatory supplemental change order for which authorization is requested in the amount of \$2,055.95; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said amendatory supplemental change order #1 to Contract No. C23-0097, issued to Perryman’s Excavating Inc., Milmay, NJ, in the amount of \$2,055.95, be and the same is hereby ratified and approved.
