RE: FY 2024 Safe Routes to School Application Memorial School ADA Walkway Improvements City Eng. No. 23-024

I respectfully request a resolution be placed on the agenda for the October 24, 2023 City Council meeting authorizing the submission of a grant application and execution of a grant agreement with NJDOT for the Memorial School ADA Walkway Improvements. The application period ends November 17, 2023.

The project scope includes upgrading sidewalk along Main Road (Landis Avenue to Chestnut Avenue) and Chestnut Avenue (Main Road to Spring Road) to comply with Federal Americans with Disabilities Act (ADA). The project location would be the East side of Main Road and the North side of Chestnut Avenue. The total project cost, see attached, is estimated at \$481,000.

In addition to support of City Council, official support is needed from the School District and County Board of Commissioners. I have discussed the project with the County Engineer earlier this week, and he is supportive.

MEMORIAL SCHOOL ADA WALKWAY IMPROVEMENTS

Memorial School ADA Walkway Improvements

SCOPE OF WORK

The scope of this project includes the removal and replacement of sidewalk along Main Road (CR 555) and Chestnut Avenue in order to ensure that this route to two (2) local K-12 schools is compliant as an accessible route in accordance with the Americans with Disabilities Act (ADA).

Along Main Road, sidewalk cross slopes vary from less than two percent (2%) to greater than twelve percent (12%). The majority of sidewalk crossing driveways are grossly deficient and portions of the sidewalk are broken or sunken, creating a hazard for pedestrians, especially those with mobility issues. Deficiencies along Chestnut Avenue are not as severe as on Main Road, but compliance with ADA is not fully met.

This project will serve students attending Veteran's Memorial School located at 424 S. Main Road and Vineland Senior High School located at 3010 E. Chestnut Avenue. The Project Location Map indicates the schools and overlap of the bussing exclusion areas.
