## **CONTRACT AGREEMENT**

# BY AND BETWEEN THE CITY OF VINELAND AND VINELAND REVOLVING LOAN FUND, LLC

WHEREAS, the parties desire to enter into an agreement providing for the funding of expenses of the Economic Development Division of the City of Vineland, effective January 1, 2024; and

WHEREAS, the funding as identified in this Agreement is for the specific purpose of meeting budgeted items of expense as identified on Exhibit "A" attached hereto and made a part hereof;

NOW, THEREFORE, THE PARTIES TO THE CONTRACT DO MUTUALLY AGREE TO THE FOLLOWING:

- 1. The Vineland Revolving Loan Fund, LLC agrees to provide funding through a grant award in the amount of \$605,037.00 to the City to cover a portion of the salaries and wages and other expenses of the Economic Development Division for the period January 1, 2024 through December 31, 2024, as shown on Exhibit "A" attached hereto.
- 2. Upon the expiration of this agreement, the City shall transfer to the Loan Fund any funds on hand at the time of expiration and any accounts receivable attributable to the use of the funds granted hereunder.
