RESOLUTION NO. 2023-635

A RESOLUTION DECLARING THE EXISTENCE OF AN EMERGENCY REQUIRING DRAINAGE REMOVAL AND REPLACEMENT ON 3RD STREET (BETWEEN 3RD STREET ANNEX & LUCIANO AVENUE) AND AUTHORIZING THE PAYMENT OF BILLS FOR SAID SERVICES.

WHEREAS, the City Engineer's Office has reported that an emergency condition has developed on 3rd Street between 3rd Street Annex and Luciano Avenue, just north of Tarkiln Branch, related to a corrugated metal storm piping failure in the westerly paved shoulder, creating a void that threatens to undermined the travel lane; and

WHEREAS, this situation poses an imminent danger to the public health and welfare if left unattended with more storms to come through and wash away even more of the roadway. Removal and replacement of the entire run of storm piping from Tarkiln Branch to the northerly manhole on 3rd Street will correct this issue; and

WHEREAS, due to this emergent situation, the City Engineer Office has solicited quotations for completion of said removal and replacements; and

WHEREAS, authorization is requested to contract with Mathis Construction Co., Inc., Little Egg Harbor, NJ for Emergency Drainage Removal and Replacement on 3rd Street between 3rd Street Annex and Luciano Avenue, in the amount not to exceed \$87,304.50; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the above emergency;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Vineland as follows:

- 1. That the City Engineer is hereby authorized and directed to contract with Mathis Construction Co., Inc., Little Egg Harbor, NJ, for Emergency Drainage Removal and Replacement on 3rd Street between 3rd Street Annex and Luciano Avenue, in the amount not to exceed \$87,304.50.
- 2. That the Purchasing Agent is hereby authorized and directed to issue purchase orders to Mathis Construction Co., Inc., Little Egg Harbor, NJ, for Emergency Drainage Removal and Replacement on 3rd Street between 3rd Street Annex and Luciano Avenue, in the amount not to exceed \$87,304.50.
- 3. That payment is hereby authorized pursuant to said purchase orders in accordance with procedures for payment of bills and demands heretofore established by Ordinance number 1048.

Please take note that an emergency condition has developed on 3rd Street between 3rd Street Annex and Luciano Avenue, just north of Tarkiln Branch.

Corrugated metal storm piping has failed in the westerly paved shoulder, creating a void that threatens to undermine the travel lane. This poses an imminent danger to the public health and welfare if left unattended with more storms to come through and wash away even more of the roadway. Removal and replacement of the entire run of storm piping from Tarkiln Branch to the northerly manhole on 3rd Street will correct this issue.

Mathis Construction is being directed to commence this work in the earliest possible timeframe. Carmen will be entering a requisition this afternoon for the work. We will be funding this through our 2023 Capital Improvement bond.
