BE IT FURTHER RESOLVED that the City Council recognizes and accepts that the Department of Community Affairs may offer a lessor or greater amount based upon all submissions and need and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the Mayor and City Clerk to execute any such grant agreement; and upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement by and between the City of Vineland and the New Jersey Department of Community Affairs.
