

RESOLUTION NO. 2024- 178

A RESOLUTION EXERCISING THE OPTION TO EXTEND CONTRACT C23-0095 FOR PRESSURE PIPING, FABRICATION AND INSTALL PROJECTS FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY.

WHEREAS, on July 25, 2023, the City Council of the City of Vineland adopted Resolution No. 2023-357, awarding an Open-End Contract to Monarch Boiler Const. Co., Inc., Blackwood, NJ, for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility, for the period commencing August 1, 2023 and end July 31, 2024, with an option to renew for one additional year, COV BID #2023-23, in the amount of \$122,554.00; and

WHEREAS, the Vineland Municipal Electric Utility and Monarch Boiler Const. Co., Inc. have agreed to exercise the one additional year option, extending Contract No. C23-0095 beginning September 1, 2024 through August 31, 2025 for an estimated amount not to exceed \$122,554.00 at the same terms and conditions of the original contract.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue an extension to Contract No. C23-0095, issued to Monarch Boiler Const. Co., Inc., Blackwood, NJ, for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility for an estimated amount not to exceed \$122,554.00 for the option year beginning September 1, 2024 through August 31, 2025, at the same terms and conditions of the original contract.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
