A RESOLUTION EXERCISING THE OPTION TO EXTEND CONTRACT C23-0090 FOR THE FURNISHING AND DELIVERY OF CEMS CALIBRATION GAS FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – GENERATION DIVISION.

WHEREAS, on June 13, 2023, City Council adopted Resolution No. 2023-260, awarding a contract to Linde Gas & Equipment, Inc., Allentown, PA for the furnishing and delivery of CEMS Calibration Gas; and

WHEREAS, the specifications included an option to renew for six additional months; and

WHEREAS, the City of Vineland Municipal Electric Utility – Generation Division and Linde Gas & Equipment, Inc., have agreed to extend the contract for the six additional months for the period July 1, 2024 through December 31, 2024 in the amount of \$31,459.96, plus a 4% increase for a total amount not to exceed \$32,718.36, at the same terms and conditions of the original contract; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that Resolution No. 2023-260 is hereby amended to allow the Purchasing Agent to issue an extension to Contract No. 23-0090, to Linde Gas & Equipment, Inc., Allentown, PA for the furnishing and delivery of CEMS Calibration Gas, for the option year beginning July 1, 2024 through December 31, 2024, in the amount of \$31,459.96, plus a 4% increase for a total amount not to exceed \$32,718.36, at the same terms and conditions of the original contract.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
