NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

- 1. The Purchasing Agent be and the same is hereby authorized to issue contract to Starnet Solutions, Inc., Farmingdale, NJ for the Arcserve Appliance 9504DR Annual Maintenance Renewal, in an amount not to exceed \$80,521.84, for the contract period beginning July 1, 2024 through June 30, 2025.
- 2. That the Business Disclosure Entity Certification, the Political Contribution Disclosure Form and the Determination of Value be placed on file with the Resolution.
- 3. Notice of this action shall be printed once in the Daily Journal.


