A RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE LANDIS SEWERAGE AUTHORITY (L.S.A.) FOR SERVICES RENDERED TO THE L.S.A. BY THE OFFICE OF THE TAX COLLECTOR FOR THE CITY OF VINELAND.

WHEREAS, N.J.S.A. 40A:65-4 (Shared Services Act), permits any local unit of the State to enter into a contract with any other local unit or units for the joint provision within their several jurisdictions of any service which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the City of Vineland agrees to provide the Landis Sewerage Authority with the services of the Tax Collector's Office, including the placement of sewer liens, collection of liens, tax searches, software maintenance, clerical and accounting work, for the period January 1, 2024 through December 31, 2024; and

WHEREAS, in consideration of said services, the L.S.A. agrees to provide compensation to the City in the amount of \$12,000.00.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Vineland, as follows:

- 1. THAT, pursuant to the provisions of N.J.S. 40A:65-4 (Shared Services Act), the Mayor and City Clerk are hereby authorized to execute a Shared Services Agreement between the City of Vineland and the Landis Sewerage Authority (L.S.A.) for services rendered to the L.S.A. by the City of Vineland Tax Collector's Office for the period January 1, 2024 through December 31, 2024 for compensation in the amount of \$12,000.00.
- 2. THAT the City of Vineland (the "Lead Agency") entering into contracts on behalf of the L.S.A. shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S. 40A:ll-l et seq.) and all other provisions of the revised statutes of the State of New Jersey.

AGREEMENT

1. The City agrees to provide the Landis Sewerage Authority with the services of the Tax Collector's Office, including the placement of sewer liens, collection of liens, tax searches, software maintenance, clerical and accounting work, for the period January 1, 2024 through December 31, 2024.

2. In consideration of said services, the L.S.A. agrees to provide compensation to the City in the amount of \$12,000.00.

3. This agreement shall be conditioned upon approval of authorizing resolutions being passed by the City and the L.S.A.
