A RESOLUTION AUTHORIZING AND APPROVING THE FILING OF AN APPLICATION WITH THE NEW DEPARTMENT JERSEY OF ENVIRONMENTAL PROTECTION FOR SUPPLEMENTAL GREEN ACRES PROGRAM FUNDING FOR ROMANO PARK COMPLEX IMPROVEMENTS (#0614-21-009) AND AUTHORIZING THE EXECUTION OF AGREEMENTS FOR SAME.

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides loans and/or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the **City of Vineland** has previously obtained a Green Acres grant of **\$1,200,000** from the State to fund the following project(s):

#0614-21-009 Romano Complex Improvements; and

WHEREAS, the State and the City of Vineland intend to increase Green Acres funding by \$1,400,000, to increase Green Acres funding to a total of \$2,600,000.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Vineland that:

- 1. The Mayor of the City of Vineland is hereby authorized to execute an agreement and any amendment(s) thereto with the State known as Romano Complex Improvements #0614-21-009.
- 2. The applicant agrees to provide its matching share to the Green Acres funding, if a match is required, in the amount of \$400,000, contingent upon the passage of a legislative appropriation in the amount of \$1,997,000.
- 3. The applicant agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project.
- 4. This resolution shall take effect immediately.


