A RESOLUTION AWARDED AN OPEN-END CONTRACT
TO ACV ENVIRONMENTAL SERVICES, INC., AVENEL, NJ
FOR SOLID AND LIQUID WASTE DISPOSAL FOR THE
VINELAND MUNICIPAL ELECTRIC UTILITY.

WHEREAS, the City of Vineland has heretofore advertised for bids for Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility, for a period of one year commencing July 1, 2024 with option to renew for one additional year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on June 4, 2024, a bid was received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of June 25, 2024 submitted a written report and tabulation of the bid received and has recommended that an open-end contract for Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility, be awarded to ACV Environmental Services, Inc., Avenel, NJ, based on unit pricing, for an estimated amount not to exceed \$60,000.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility, for a period of one year commencing July 1, 2024 with option to renew for one additional year, be and the same is awarded to ACV Environmental Services, Inc., Avenel, NJ, based on unit pricing, for an estimated amount not to exceed \$60,000.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.


