

RESOLUTION NO. 2024- 306

A RESOLUTION OF THE CITY OF VINELAND GRANTING AN AMUSEMENT GAME LICENSE TO LEO ENTERTAINMENT LLC d/b/a 810 BILLIARDS, TO OPERATE AT THE PREMISES LOCATED AT 3679 SOUTH DELSEA DRIVE, VINELAND NJ.

WHEREAS, LEO Entertainment, LLC, d/b/a 810 Billiards Vineland NJ, has submitted an application to the Office of the City Clerk of Vineland for an Amusement Games License for calendar year 2024 pursuant to the Amusement Games Licensing Law, N.J.S.A. 5:8-100 et seq., and such regulations as promulgated under Chapter 3, Office of Amusement Games Control, N.J.A.C. 13:3-1.1 et seq., to operate at its location at 3679 South Delsea Drive, Vineland NJ; and

WHEREAS, N.J.A.C. 13:3-1.13(a) provides that no license shall be issued in any municipality unless and until the issuance thereof has been authorized by a resolution duly adopted by the municipal governing body; and

WHEREAS, in 2017, the State of New Jersey enacted N.J.S.A. 5:8-78.2 that allows a qualified bowling alley eligible to be issued an Amusement Game License, provided all other requirements for licensure are met; and

WHEREAS, N.J.S.A. 5:8-78.2 provides that no license shall be issued in any municipality unless and until the operator of a bowling alley located anywhere in this State, including a bowling alley for which a plenary retail consumption license is defined in R.S. 33:1-12 has been issued, whose premises include no less than 16 United States Bowling Congress (USBC) sanctioned bowling lanes and no less than 40 amusement games, shall be eligible to be issued for that premises an amusement game license pursuant to P.L. 1959, c.109 (C.5:8-100 et seq.), provided that all other requirements for licensure to conduct amusement games are met; and

WHEREAS, on March 26, 2024 the City Council of the City of Vineland adopted Ordinance 2024-19 to comply with statutory guidelines thereby authorizing the issuance of licenses for amusement games and fixing annual license fees in accordance with N.J.A.C. 13:3-1.5(a)(2); and

WHEREAS, the City of Vineland designates LEO Entertainment LLC, d/b/a 810 Billiards, located at 3679 S. Delsea Drive, Vineland New Jersey, as permitted to hold an Amusement Game License in accordance with the requirements of N.J.S.A. 5:8-78.2; and

WHEREAS, the Vineland Police Department has submitted a written report that the owner of LEO Entertainment has successfully completed a background check and is cleared for approval to hold an Amusement Games License to be associated with this Plenary Retail Consumption License 0614-33-027-015; and

WHEREAS, the City Clerk has deemed the application of LEO Entertainment, LLC d/b/a 810 Billiards, complete.

NOW, THEREFORE, BE IT RESOLVED, on this 9<sup>th</sup> day of July, 2024, by Council of the City of Vineland, that LEO Entertainment, LLC d/b/a 810 Billiards is hereby GRANTED an Amusement Games License in accordance with N.J.S.A. 5:8-78.2 to operate at premises 3679 S. Delsea Drive, Vineland New Jersey; and

BE IT FURTHER RESOLVED pursuant to N.J.A.C. 13:3-1.13(b), a certified copy of this Resolution, together with a copy of any application endorsed to show the granting of a municipal license to LEO Entertainment, LLC d/b/a 810 Billiards, that the Municipal Clerk of the City of Vineland is hereby ordered to issue the licenses as directed and shall be transmitted to the Legalized Games of Chance Control Commission within three business days of the municipal license being granted.
