## ORDINANCE NO. 2024-\_\_\_\_44

ORDINANCE AMENDING ORDINANCE 2017-57, CHAPTER 81 OF THE CODE OF THE CITY OF VINELAND ENTITLED LANDIS THEATER FOUNDATION BOARD OF DIRECTORS

**WHEREAS,** on August 22, 2017, City Council adopted Ordinance 2017-57, as amended, Chapter 81 of the Code of the City of Vineland entitled Landis Theater Foundation Board of Directors which set forth the number and method of appointment of members of the Board; and

**WHEREAS**, it has been recommended that the present number of members at 11 is too large of a number which rarely allows for a quorum and a smaller number will be easier with which to operate; and

**WHEREAS**, it is recommended that the members be amended as well so that the Board consists of the Mayor, member of City Council, the Economic Development Director, a member of the community involved in the arts or education and a member of the community involved with a social or cultural organization; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Vineland that Chapter 81, Section 81-1 be deleted in its entirety and replaced as follows:

## Section 81-1 Appointment and recommendation of members, terms of office.

- A. The Board of Trustees of the Landis Theater Foundation shall consist of five (5) members and shall serve a term of office as follows:
  - (1) the Mayor who shall serve coterminous with his or her term(s) of office.
  - (2) a member of City Council appointed by the Mayor who shall serve at the pleasure of the mayor subject to removal or replacement at the discretion of the Mayor
  - (3) the Director of Economic Development who shall serve coterminous with his or her term(s) of office
  - (4) a community member involved in the arts or education appointed by the Mayor who shall serve for a term of four (4) years which shall commence upon the expiration of the current term which expiration is December 31, 2026.
  - (5) a community member involved in a social or cultural organization appointed by the Mayor who shall serve for a term of four (4) years which shall commence upon the expiration of the current term which expiration is December 31, 2027.

**BE IT FURTHER ORDAINED** that the balance of Ordinance 2017-57 not amended hereby shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that should any portion of this Ordinance be deemed unenforceable by a court of competent jurisdiction, that portion so determined to be unenforceable, shall be void and the balance hereof shall remain in full force and effect.

## CITY OF VINELAND

This Ordinance shall take effect upon adoption and publication according to law.
