RESOLUTION NO. 2024- 338

A RESOLUTION RATIFYING AND CONFIRMING THE RE-APPOINTMENT OF JOHN ARMANO, ESQUIRE, TO THE POSITION OF JUDGE, VINELAND MUNICIPAL COURT.

WHEREAS, Ordinance No. 4 established the position of Judge of the Municipal Court of the City of Vineland; and

WHEREAS, N.J.S.A. 2B:12-4 states that each Judge of a Municipal Court shall serve for a term of three (3) years from the date of his/her appointment and until his/her successor is appointed and qualified; and

WHEREAS, the Judge of the Municipal Court shall be appointed by the Mayor with the advice and consent of the City Council; and

WHEREAS, the Mayor of the City of Vineland has appointed John Armano, Esq. to serve as the Judge of the Vineland Municipal Court subject to the ratification and confirmation thereof by City Council; and

WHEREAS, after consideration of the Mayor's recommended appointment as well as the qualifications of John Armano, Esq. the Council of the City of Vineland ratifies and confirms the appointment of John Armano, Esq. to the position of Judge of the Vineland Municipal Court, Part Time, with a salary in accordance with the City of Vineland salary ordinance for a period of three years which appointment shall continue until reappointed or replaced in accordance with N.J.S.A. 2B:12-4.

NOW, THEREFORE, BE IT RESOLVED, that the Council of the City of Vineland ratifies and confirms the action of the Mayor of the City of Vineland in appointing John Armano, Esq. as Judge of the Municipal Court of the City of Vineland for the statutory term of three (3) years, which term commences August 1, 2024 until replaced or re-appointed in accordance with N.J.S.A. 2B:12-4.

BE IT FURTHER RESOLVED that the Mayor and Solicitor are hereby authorized to execute a Professional Services Agreement for judicial services for the Vineland Municipal Court in the form and substance as attached hereto and made a part hereof, subject to non-material changes as approved by the City Solicitor.
