A RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, INSIGHT PUBLIC SECTOR, INC, CHANDLER , AZ FOR IBM MAXIMO APPLICATION SUITE SUBSCRIPTION.

WHEREAS, the City of Vineland pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the City of Vineland intends to enter into a contract with a State Contract Vendor for IBM Maximo Application Suite Subscription, through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts;
