RESOLUTION EXERCISING THE (1) ONE YEAR CONTRACT EXTENSION TO CONTRACT C23-0106 FOR MOBILE DEMINERALIZER SYSTEM- FOR UNIT 11 & CLAYVILLE UNIT 1.

WHEREAS, on October 10, 2023, City Council adopted Resolution No. 2023-473, to include the option to renew for another (1) one year term per bid specifications and open-end Contract No. C23-0106 to MPW Industrial Water Services, Inc., Hebron, OH for Mobile Demineralizer System for Unit 11 & Clayville Unit 1; and

WHEREAS, the Director of Electric Utility and MPW Industrial Water Services, Inc. have agreed to extend the contract for the additional one (1) year term for the period of November 1, 2024 through October 31, 2025, in the estimated revised amount of \$198,480.00 at the same terms and conditions of the original contract; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue the one (1) year option renewal for Contract No. C23-0106 issued to MPW Industrial Water Services, Inc., Hebron, OH for Mobile Demineralizer System for Unit 11 & Clayville Unit 1, for the period November 1, 2024 through October 31, 2025, in the estimated revised amount of \$198,480.00, at the same terms and conditions of the original contract.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
