RESOLUTION NO. 2024- 440

A RESOLUTION DECLARING THE EXISTENCE OF AN EMERGENCY REQUIRING REPAIR OF A SINK HOLE AT THE INTERSECTION OF LANDIS AVE. & MILL ROAD AND AUTHORIZING THE PAYMENT OF BILLS FOR SAID SERVICES.

WHEREAS, the City Engineer's Office has reported that an emergency condition has developed at the intersection of Landis Avenue and Mill Road in which a sink hole has formed about 100 ft. south of the Landis & Mill intersection on Jul 17th. The collapse caused a large void in the roadway that posed an imminent hazardous condition to the public health and welfare.

WHEREAS, this situation poses an imminent danger to the public health and welfare if left unattended. Removal and replacement of the drainage pipe was necessary for the emergency drain repair at Landis Avenue and Mill Road to correct this issue; and

WHEREAS, due to this emergent situation, the City Engineer Office has solicited quotations for completion of said removal and replacements; and

WHEREAS, authorization is requested to contract with Perna Finnigan, Inc., Vineland, NJ for emergency drainage repair at the intersection of Landis Avenue and Mill road not to exceed \$29,720.00; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the above emergency;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Vineland as follows:

1. That the City Engineer is hereby authorized and directed to contract with Perna Finnigan, Inc., Vineland, NJ, for Emergency Drainage Removal and Replacement on Landis Avenue and Mill Road, in the amount not to exceed \$29,720.00.

2. That the Purchasing Agent is hereby authorized and directed to issue purchase orders to Perna Finnigan, Inc., Vineland, NJ, for Emergency Drainage Removal and Replacement on Landis Avenue and Mill Road, in the amount not to exceed \$29,720.00.

3. That payment is hereby authorized pursuant to said purchase orders in accordance with procedures for payment of bills and demands heretofore established by Ordinance number 1048.

MEMORANDUM TO BUSINESS ADMINISTRATION:


RE: Emergency Drainage Repairs due to sink hole on Landis Ave. & Mill Rd.

On Thursday, August 29, 2024 I received an email from Rick Caudill, Supervising Engineer concerning the emergency that occurred at Landis Avenue and Mill Road. According to Rick, he encountered a sinkhole that popped up about 100 ft. south of the Landis Avenue & Mill Road intersection around Jul 17th. The collapse caused a large void in the roadway that posed an imminent hazardous condition to the public health and welfare. Since they had a lot of traffic control conflicts with the Landis Phase 5 project, They had Perna Finnigan give them two quotes – one for day work and one for night work. They moved forward with the Day Work quote once South State cleared the area. The sinkhole was temporarily stabilized but it was not going to hold long-term. The work was completed about two weeks ago.

In accordance with N.J.S.A. 40A:11-6 Emergency Contracts, I as the Purchasing Agent of the City of Vineland, agree that this situation can be a health, safety and welfare issue as defined by the NJ Public Contracts Law and should be declared an “Emergency”.

I have instructed the Department to enter requisitions in the Edmunds Finance System to Perna Finnigan, Inc., in the amount of \$29,720.00 to immediately repair the emergency work needed.
