WHEREAS, the Business Administrator has, under date of November 18, 2024 submitted a written report and tabulation of the bids received and has recommended that a contract for 2024 Citywide Linstripping, be awarded to Swayze & Son, Inc., Scotch Plains, NJ, in the total amount of \$69,810.90, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for 2024 Citywide Linstripping, be and the same is awarded to Dan Swayze & Son, Inc., Scotch Plains, NJ, on their total bid in the amount of \$69,810.90, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and
