

RESOLUTION NO. 2024- 574

A RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO STARNET SOLUTIONS INC., FARMINGDALE, NJ, FOR THE PURCHASE OF N-ABLE AND N-CENTRAL WITH ONE (1) YEAR SUPPORT RENEWAL, IN AN AMOUNT NOT TO EXCEED \$52,401.00.

WHEREAS, there exists a need to renew N-Able and N-Central with one (1) year Support Renewal; and

WHEREAS, the City of Vineland has a need to acquire such service as a Non-Fair and Open Contract pursuant to N.J.S.A. 19:44A-20.5; and

WHEREAS, the purchasing agent has determined and certified in writing that the value of said services will exceed \$17,500.00; and

WHEREAS, it has been recommended that a contract be awarded to Starnet Solutions Inc., Farmingdale, NJ for the purchase of N-Able and N-Central with one (1) year Support Renewal, commencing on December 1, 2024 and ending on November 30, 2025, in an amount not to exceed \$52,401.00; and

WHEREAS, Starnet Solutions Inc. has completed and submitted a Business Entity Disclosure Certification for Non-Fair and Open Contract which certifies that Starnet Solutions Inc. has not made any reportable contributions to a political or candidate committee in the City of Vineland in the previous one year and that the contract will prohibit Starnet Solutions Inc. from making any reportable contributions through the term of the contract to a political or candidate committee in the City of Vineland; and

WHEREAS, the availability of funds for said contract to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

1. This contract is awarded without competitive bidding in accordance with 40A:11-5(1)(dd) of the Local Public Contracts Law for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software, except that this provision shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software.
2. The Purchasing Agent be and the same is hereby authorized to issue contract to Starnet Solutions Inc., Farmingdale, NJ, in an amount not to exceed \$52,401.00 for the purchase of N-Able and N-Central with one (1) year Support Renewal, commencing on December 1, 2024 and ending on November 30, 2025.
3. That the Business Disclosure Entity Certification, the Political Contribution Disclosure Form and the Determination of Value be placed on file with the Resolution.
4. Notice of this action shall be printed once in the Daily Journal.

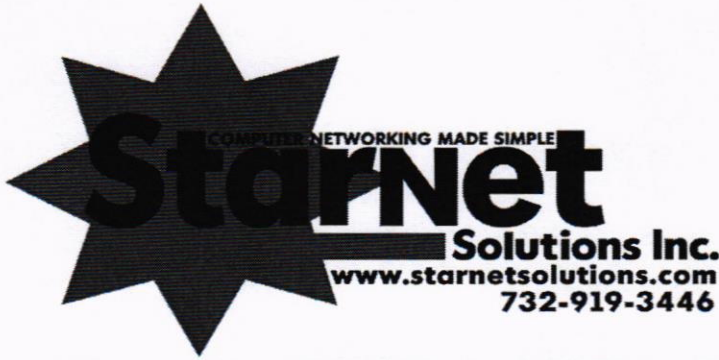
