RESOLUTION EXERCISING THE SECOND OPTION YEAR RENEWAL TO CONTRACT FOR MARKETING, ADVERTISING, PROMOTIONAL AND PUBLIC RELATIONS/CONSTITUENT CONSULTING SERVICES.

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue an extension to Contract No. C23-0004, issued to Lee Tofanelli and Associates, Inc., Vineland, NJ, for Marketing, Advertising, Promotional and Public Relations/Constituent Consulting Services, beginning February 1, 2025 and ending January 31, 2026, for the total amount of \$111,600.00 (\$6,850.00 monthly retainer fee plus a \$2,450.00 monthly website development Maintenance & Management fee) in accordance with Resolution No. 2023-05.


