RESOLUTION RATIFYING AND CONFIRMING THE APPOINTMENT OF JEANINE N. MENEGHETTI AS THE PUBLIC AGENCY COMPLIANCE OFFICER (P.A.C.O.) IN ACCORDANCE WITH N.J.A.C. 17:27-3.3(a).

WHEREAS, in accordance with N.J. A.C. 17:27-3.3(a), Equal Employment Opportunity and Affirmative Action Rules, each public agency shall annually designate an officer or employee to serve as its Public Agency Compliance Officer and shall notify the Division of Public Contracts Equal Employment Opportunity Compliance established in the State of New Jersey Department of the Treasury (Division); and

WHEREAS, Jeanine N. Meneghetti is the City's Qualified Purchasing Agent and is responsible for review of Procurement and Service contracts as well as Construction Contracts for which bids have been solicited or negotiated pursuant to the Local Public Contracts; and

WHEREAS, the City must annually designate an officer or employee to serve as its Public Agency Compliance Officer; and

WHEREAS, the Mayor has recommended Jeanine N. Meneghetti be appointed for the next term which shall expire on December 31, 2025.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Vineland that the appointment of Jeanine N. Meneghetti as the Public Agency Compliance Officer effective immediately upon the passage of this Resolution to serve until December 31, 2025 and that notification of this appointment be submitted to the Division of Public Contracts Equal Employment Opportunity Compliance in the Department of the Treasury.
