

RESOLUTION NO. 2024- 618

A RESOLUTION AUTHORIZING THE USE OF CONTRACTS WITH EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY (ESCNJ) #65-MCESCCPS COOPERATIVE PRICING SYSTEM VENDORS FOR CALENDAR YEAR 2025.

WHEREAS, the City of Vineland is a member of the Educational Services Commission of New Jersey (ESCNJ) (formerly known as Middlesex Regional Educational Services Commission) #65-MCESCCPS Cooperative Pricing System pursuant to N.J.S.A. 40A:10, 11 & N.J.A.C. 5:34-7.3, 7.4, 7.12 and Resolution 2014-444 adopted on October 28, 2014 by the City of Vineland’s City Council; and

WHEREAS, the City of Vineland has the need, on a timely basis, to purchase goods or services by utilizing ESCNJ Cooperative Pricing System Contracts & Vendors; and

WHEREAS, the City of Vineland may enter into contractual agreements with the ESCNJ Contract Vendors through this resolution and properly executed contracts/purchase orders, which shall be subject to all the conditions applicable to the current New Jersey Local Public State Contracts Law; and

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Vineland, New Jersey authorizes the City Purchasing Agent to purchase certain goods or services from the approved ESCNJ Contract Vendors, pursuant to all conditions of the ESCNJ individual Contracts; and

BE IT FURTHER RESOLVED, that the Educational Services Commission of New Jersey #65-MCESCCPS Contract vendors and their corresponding numbers may change during the timeframe indicated below and that the City Purchasing Agent is hereby authorized to make the necessary adjustments to the vendor list as may be required for the City to continue its routine procurement practices throughout the indicated timeframe; and

BE IT FURTHER RESOLVED, that the City Council of the City of Vineland, pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds and that no contract amount shall be chargeable or certified until such times as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds shall be made by the City’s Chief Financial Officer; and

BE IT FURTHER RESOLVED that the duration of the contracts between the City of Vineland and the Educational Services Commission of New Jersey #65-MCESCCPS Contract Vendors shall be for Calendar Year 2025 or until the expiration of the referenced vendor’s contract, whichever shall occur first.
