WHEREAS, the City of Vineland has heretofore advertised for bids for the Reconstruction of N. Second Street (Landis Avenue to Wood Street), COV BID #2024-56, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on November 19, 2024, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of March 4, 2025 submitted a written report and tabulation of the bids received and has recommended that a contract for the Reconstruction of N. Second Street (Landis Avenue to Wood Street), be awarded to Charles Marandino, LLC, Milmay, NJ, in the amount not to exceed \$272,373.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the Reconstruction of N. Second Street (Landis Avenue to Wood Street), COV BID #2024-56, be and the same is awarded to Charles Marandino, LLC, Milmay, NJ on their bid in the amount of \$272,373.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
