## **ORDINANCE NO. 2025**-<u>38</u>

## ORIDNANCE AMENDING ORDINANCE 2015-14, AS AMENDED, CHAPTER 123, ARTICLE III, SECTION 123-24 OF THE CODE OF THE CITY OF VINELAND ENTITLED COMPENSATION OF SPECIAL LAW ENFORCEMENT OFFICERS

WHEREAS, on March 10, 2015 City Council adopted Ordinance 2015-14, as amended setting forth the compensation rate for Class I, Class II and Class III special law enforcement officers (SLEO) in the City of Vineland Police Department and

**WHEREAS**, the salaries have not been adjusted for 4 years and the present rates are below the rates of compensation being received by SLEO's in other communities making it difficult to recruit said officers; and

**WHEREAS**, the Director of Public Safety and Acting Chief of Police have recommended the salaries be increased so they are equivalent with other communities; and

**WHEREAS**, Council finds it to be in the best interest of the City and Vineland Police Department to increase said salaries.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Vineland that Ordinance 2015-14, as amended, Chapter 123, Article III, Section 123-24 be amended as follows:

Sections 123-24 A, B and C shall be deleted in their entirety and replaced as follows:

A. Class One Officer: \$20 to \$25 per hour.

- B. Class Two Officer with less than 25 years of law enforcement experience: \$25 to \$30 per hour.
- C. Class Two Officer with 25 years or more of law enforcement experience \$40 to \$45 per hour

Section 123-24 F shall be added as follows:

F. Salary adjustments for Class One and Class Two Officers shall not be less than salary adjustments granted to blue-collar and clerical employees covered by a collective bargaining agreement. If a Special Law Enforcement Officer is covered by an individual employee agreement, then salaries and other terms and conditions of employment shall be governed by the individual employee agreement.

**BE IT FURTHER ORDAINED** that the balance of Ordinance 2015-14, as amended, Chapter 123 Article III, Section 123-24 of the Code of the City of Vineland not amended hereby shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that should any portion of this Ordinance be deemed unenforceable by a court of competent jurisdiction, that portion so determined to be unenforceable, shall be void and the balance hereof shall remain in full force and effect.
