A RESOLUTION AMENDING RESOLUTION NO. 2025-28 AND AUTHORIZING THE EXECUTION OF AN AMENDMENT THE SHARED ТО SERVICES AGREEMENT BY AND BETWEEN THE COUNTY OF CUMBERLAND AND THE CITY OF VINELAND FOR THE PROVISION OF THE CODE BLUE WARMING **CENTER.** 

WHEREAS, on January 14, 2025, the City Council of the City of Vineland, adopted Resolution No. 2025-28, approving the execution of a Shared Services Agreement between the County of Cumberland and the City of Vineland that allocated \$25,000.00 of Code Blue funding by the New Jersey Department of Human Services through the County of Cumberland to the City of Vineland for the provision of the Code Blue Warming Centers; and

WHEREAS, after Resolution No. 2025-28 was approved and the Shared Services Agreement was executed, the New Jersey Department of Human Services allocated additional Code Blue funding for the 2025 Social Services for the Homeless grant program, with \$25,000.00 in additional funding allocated to the City of Vineland by the County of Cumberland, conditioned upon the funds being used exclusively for the provision of services that directly support emergency sheltering of the homeless in the City of Vineland; and

WHEREAS, City Council has determined it to be in the best interests of the City to amend Resolution No. 2025-28 to authorize the execution of an Amendment to the Shared Services Agreement providing for the receipt by the City of the additional \$25,000.00 from the County of Cumberland to be used for the provision of services that directly support emergency sheltering of the homeless within the City of Vineland.

**NOW THEREFORE BE IT RESOLVED** by the Council of the City of Vineland that Resolution No. 2025-28 is hereby amended as follows:

1. The Mayor and Clerk are authorized to execute an Amendment to the Shared Services Agreement between the City of Vineland and the County of Cumberland for the provision of additional funding in the amount of \$25,000.00 to be used for the provision of services that directly support emergency sheltering of the homeless within the City of Vineland from January 1, 2025 until December 31, 2025 in the form and substance as attached hereto and made a part hereof.

## AMENDMENT TO SHARED SERVICES AGREEMENT BETWEEN THE COUNTY OF CUMBERLAND AND THE CITY OF VINELAND REGARDING "CODE BLUE" WARMING CENTER

This is an amendment to the Shared Services Agreement Regarding "Code Blue" Warming Centers entered into by and between the **CITY OF VINELAND**, a public body corporate and politic of the State of New Jersey, whose address is 640 E. Wood Street, PO Box 1508, Vineland NJ 08362 (hereinafter "**VINELAND**").

The New Jersey Department of Human Services has allocated additional Code Blue funding for the 2025 Social Services for the Homeless grant program. The City of Vineland shall receive additional funds in the amount of \$25,000.

Section #2 of the Agreement is hereby amended as follows:

2. The Agreement is amended for the additional \$25,000. CUMBERLAND shall allocate the total amount of FIFTY THOUSAND DOLLARS (\$50,000) to VINELAND to be used exclusively for the provision of services that directly support emergency sheltering of the homeless within the City of Vineland.

All other terms and conditions of the original Agreement shall remain unchanged.

## RESOLUTION AUTHORIZING AMENDMENTS TO THE SHARED SERVICE AGREEMENTS BETWEEN THE COUNTY OF CUMBERLAND AND THE CITIES OF BRIDGETON, MILLVILLE, AND VINELAND CONCERNING "CODE BLUE WARMING SHELTERS (ADDITIONAL \$25,000.00 TO EACH MUNICIPALITY)

WHEREAS, the County of Cumberland has received additional grant funding in the amount of \$75,000.00 from the New Jersey Department of Human Services to support local efforts to provide emergency warming centers for the duration of a Code Blue Alert; and

WHEREAS, such "Code Blue" warming centers are located within, or provides such services, to those individuals within the Cities of Bridgeton, Millville and Vineland; and

WHEREAS, the County has contributed by shared services agreements a total amount of \$25,000 to the City of Vineland; \$25,000 to the City of Millville; and \$25,000 to the City of Bridgeton towards support and services for the "Code Blue" Shelters

WHEREAS, the County of Cumberland, as a result of receiving the additional funding of \$75,000.00 from the State of New Jersey, is desirous of allocating additional funding and amending the shared service agreements to reflect total sums awarded as follows:

City of Vineland	\$ 50,000
City of Millville	\$ 50,000
City of Bridgeton	\$ 50,000

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CUMBERLAND, as follows: 1. That this Board hereby authorizes amendments to the shared service agreements to adjust amounts allocated.

2. That said increases shall be charged to Line-Item Appropriation or Account No. G-02-D5-789-614-998 in the total amount of \$75,000.00 (representing additional amount of \$25,000 each to the City of Vineland, the City of Bridgeton and the City of Millville).
