RESOLUTION EXERCISING THE (1) ONE YEAR CONTRACT EXTENSION TO CONTRACT C24-0113 FOR OPEN END CONTRACT FOR SOLID AND LIQUID WASTE DISPOSAL FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY.

WHEREAS, on June 25, 2024, City Council adopted Resolution No. 2024-280, to include the option to renew for another (1) one year term per bid specifications and open-end Contract No. C24-0113 to ACV Environmental Services, Inc., Clayton, NJ for Open End Contract for Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility; and

WHEREAS, the Supervising Personnel of the Electric Utility and ACV Environmental Services, Inc. have agreed to extend the contract for the additional one (1) year term for the period of July 1, 2025 through June 30, 2026, in the amount not to exceed of \$60,000.00 at the same terms and conditions of the original contract; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue the one (1) year option renewal for Contract No. C24-0113 issued to ACV Environmental Services, Inc., Clayton, NJ for Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility, for the period July 1, 2025 through June 30, 2026, in the estimated amount not to exceed of \$60,000.00, at the same terms and conditions of the original contract.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
