### A RESOLUTION AUTHORIZING EXTRAORDINARY, UNSPECIFIABLE SERVICES AGREEMENTS FOR HEALTH BENEFIT COVERAGES FOR EMPLOYEES OF THE CITY OF VINELAND (PRESCRIPTION).

WHEREAS, there exists a need for the placement of Prescription Coverages for employees of the City of Vineland; and

WHEREAS, Allen Associates, Vineland, NJ, has submitted proposals indicating the services to be rendered by the provider stated below; and

WHEREAS, the availability of funds for said contract has been certified by the Chief Financial Officer; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:ll-l et seq.) requires that the resolution authorizing the award of contracts for "Extraordinary, Unspecifiable Services" without competitive bids and the contract itself must be available for public inspection; and

WHEREAS, the Business Administrator has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

- 1. That the Mayor and Clerk are hereby authorized and directed to execute Non-Fair and Open Agreements and other related documents on behalf of the City of Vineland pursuant to N.J.S.A. 19:44A-20.5.
- 2. That the Business Disclosure Entity Certification, the Political Contribution Disclosure Form and the Determination of Value be placed on file with this Resolution.
- 3. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contracts for placement of Prescription coverages, as follows:

RxAlliance/PEBT – Enclosed is the renewal documentation for the prescription program with The RxAlliance/PEBT, effective July 1, 2025, through June 30, 2026. Your renewal rates reflect a 19.75% increase over your current rates, detailed on the attached rate sheet. While we acknowledge this is a high renewal, it is important to note that it remains under trend relative to the rest of the market.

Specialty drugs like Humira and Stelara continue to be a major factor in rising healthcare costs. These medications, while crucial for managing chronic conditions and improving patient outcomes, pose significant pricing challenges. In fact, specialty claims now account for 47% of total spend but only 2% of total claims, highlighting their outsized impact on overall costs. Additionally, the growing demand for diabetes and weight loss drugs has substantially impacted healthcare expenditures, placing further strain on prescription programs due to their high costs.

Despite these challenges, The RxAlliance has successfully maintained program costs. Through Benecard's effective management strategies, strategic planning, and the collective strength of our member groups, we remain competitive in addressing these rising pharmaceutical expenses. Benecard has reviewed the prescription benefit program activities to date for the current plan year and is pleased to offer the following program renewal. The new program charges will become effective July 1, 2025 expiring June 30, 2026 and reflect an overall increase of approximately 19<sup>3</sup>/<sub>4</sub>%. These program charges are contingent upon the Benecard/PEBT Trust Agreement remaining active for the term, City of Vineland remaining a member of the PEBT, and signing and returning the 2025-2026 Benecard agreement prior to July 1, 2025. This offering will remain valid for (60) days.

The proposed renewal program charges provided below do not account for any Federal and/or State government programs, fees, taxes or regulations including, but not limited to, the Patient Protection and Affordable Care Act with the exception of certain preventive health services and coverage for dependents to the age 26. The proposed renewal program charges also assume that the present benefit design, co-pay structure, and participation level will remain unchanged. Should any of these factors change during the contract period, Benecard reserves the right to revise these program charges. The proposed program charges include insurance carrier charges by Heartland Fidelity Insurance Company. These charges guarantee program costs by the carrier for the contract period.

It is our understanding that the City of Vineland's acceptance of this proposal is based on their request to have a separate OOP limit combined with all other essential health benefit OOP limits that does not exceed the annual limitation on the OOP's for that year as outlined by the Department of Labor. The Rx OOP limits are subject to change if the ACA OOP limits are modified. Benecard reserves the right to revise the City of Vineland's prescription benefit program charges if the client modifies or implements a different copayment level, coinsurance, deductible or any other benefit design change, including a change to the OOP amount that differs from what was used for underwriting purposes to develop for the program charges provided herein or enacts a change after inception of the new contract start date.

# The Impact of GLP-1 Drugs

- Prescription drug costs are rising due to:
  - Increased utilization of GLP-1 drugs
  - Growing expenses of specialty medications
- This trend is expected to continue beyond 2024:
  - Wegovy patent could last until 2032
  - Introduction of oral GLP-1 formulations may further escalate costs
- Recent industry-wide spending trends:
  - Costs for Wegovy, Ozempic & Rybelus doubled
  - Costs for Mounjaro & Zepbound rose by 373%
  - Ave. monthly claim cost for GLP-1s is approx. \$1,300

### The Continued Growth of Specialty Medications

- Benecard's effective strategies demonstrate the ability to manage the impact of specialty prescriptions while still ensuring access.
- Benecard's specialty spending:

# Innovative Management Strategies Considerations

Targeted Coverage:

- Limit coverage to patients with clinically severe obesity.
- Exclude Oral Tablets:
  - Exclude coverage for new oral GLP-1 drugs for both weight loss and type 2 diabetes.
- Limit Fills:
  - Cap all oral and non-oral GLP-1 drugs approved for weight loss to twelve 30-day supplies per member for a lifetime max.
  - Optional grandfathering for current users.

\* Based on utilization of GLP-1 drugs since the beginning of 2024 compared to the same period in 2023 (January - August).
