NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue the one (1) year option renewal for Contract No. C24-0112 issued to Caterina Supply Inc., 1271 Glassboro Road, Williamstown, NJ for the Open-End Contract for the furnishing and delivery of Mueller Fire Hydrants, for the period June 11, 2025 to June 10, 2026, in the estimated amount not to exceed \$212,079.00, at the same terms and conditions of the original contract.
