The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Anthony R. Fanucci.

The Municipal Clerk reviewed the changes to the agenda since the August 4 work session. A revised version of Resolution No. 2015-323 was distributed. Resolution No. 2015-334, granting the renewal of alcoholic beverage plenary retail consumption licenses, club licenses and plenary retail distribution licenses for the licensing period July 1, 2015 to June 30, 2016, was added. Resolution No. 2015-335, authorizing the place-to-place transfer of plenary retail consumption license No. 0614-32-041-010 issued to Grupo Sosa, Inc., t/a Tropical, from inactive pocket license to premises located at 523 E. Landis Avenue, Vineland, NJ, was added. Resolution No. 2015-336, authorizing the execution of an agreement modification No. 2 with the NJ Department of Transportation with respect to the resurfacing of Landis Avenue, Phase I, from Myrtle Street to Boulevard, was added. Resolution No. 2015-337, awarding a contract to Charles Marandino, LLC, Milmay, NJ, for the completion of Landis Avenue resurfacing project, Phase I, in the amount of \$2,054,207.00, was added. Resolution No. 2015-338, awarding a contract to Shelby Mechanical, Inc., Cinnaminson, NJ for completion of removal, fabrication, installation and repairs of piping at Clayville Unit #1 for the Vineland Municipal Electric Utility – Generation Division, was added.

Councilman Spinelli stated that the Jersey Fresh Festival went fine.
