The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Anthony R. Fanucci.

President Fanucci led the Pledge of Allegiance.

The Deputy Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 15, 2014 by the City Clerk in the following manner:

The Deputy Clerk reviewed the changes to the agenda since the September 15 work session. A revised version of Ordinance No. 2015-43, providing for no parking restrictions along DeMarco Drive and Industrial Way, was provided. A revised version of Resolution No. 2015-384, authorizing a letter of agreement between the Cumberland-Cape Atlantic YMCA and the City of Vineland to provide the services required to support the NJ Partnership for Healthy Kids Project, was provided. A revised version of Resolution No. 2015-385, authorizing the acceptance of a grant from the Food and Drug Administration for the limited competition: advancing conformance with the voluntary national retail food regulatory program standards, was provided. Resolution No. 2015-399, authorizing exclusion of the public from a meeting between the Mayor, members of City Council, City Clerk and staff, City Solicitor and staff, Assistant Business Administrator and staff, the City Comptroller/Finance Officer and staff and Labor Counsel and staff concerning any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body and authorizing disclosure of minutes of said meeting as provided herein, was added. Resolution No. 2015-400, authorizing the issuance of an amendatory supplemental change order No. 1 to Contract No. C15-0084, issued to Shelby Mechanical, Inc., Cinnaminson, NJ in an amount not to exceed \$100,000.00.

The Deputy Clerk assisted Council members with the dialogue sheet changes.
