

PRE-MEETING CONFERENCE

The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

The Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 12, 2018 by the City Clerk in the following manner:

President Spinelli asked if anyone from the public would like to comment.

There being no one to be heard, the Clerk reviewed changes to the agenda since the October 1 work session. Resolution No. 2019-431, authorizing the execution of a shared service agreement by and between the City of Vineland and Cumberland County Improvement Authority, Millville, NJ, for services to be provided by the City and fees to be paid by the Cumberland County Improvement Authority for property known as Block 2801, Lots 5, 9, 10, and 11 on the tax map of the City of Vineland, was added.

Solicitor Tonetta announced that an agreement is forthcoming with an Italian company who will make prosciutto here in Vineland.

Councilman Vargas noted several recent incidents at Landis Park, including an overdose. He strongly believes a police presence is important there. Public Safety Director Alicea responded that he will contact Chief Beu immediately after tonight's meeting to advise him of the concern.

Councilman Acosta reported that the Planning Board meets tomorrow.

President Spinelli noted the Genesis show at Landis Theater this Saturday; the AC/DC show next month. The George Perez mural will be dedicated on Veteran's Day, prior to the usual ceremony at Landis Park. The VDID is preparing for the annual Christmas parade.
