The Regular Work Session of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

The Health Department is putting together information for deer hunting season next week, to minimize any COVID-19 outbreaks. November ended with over 400 positive cases in Vineland, and just today, there were 37 positive cases to begin December.

Councilwoman Arthur commented that she enjoyed the Christmas parade, which was well attended. She also thanked Mr. Lewis for providing vehicles for Council members.

The issue of the VDID not utilizing the downtown speaker system to play season music was raised again. VDID has not been playing music because of licensing for intellectual property. It was suggested that recordings of our Vineland High School musicians and choir may be a way to solve the problem. Solicitor Tonetta will explore the music licensing issue further and provide guidance.

Councilman Vargas reported that all recreational fields are closed for the winter. Repairs at the various fields and parks are ongoing where needed.

Councilman Franceschini shared that he recently noticed West Side Park is looking rather shabby.

President Spinelli inquired about an update about the hero vehicle. Administrator Dickenson will check on it and get back to him. President Spinelli also thanked Mr. Lewis. He congratulated the VDID for a nice Christmas parade and extended thanks to the departments of Public Works and Fire for their assistance.
