There being no one to be heard, the Deputy Clerk reviewed revisions and additions to the agenda.

Resolution 2021-524, authorizing award of a contract to Datavoice International Inc. Chicago, IL, for Datavoice annual software maintenance and subscription, in an amount not to exceed \$46,763.80 was revised to correct the contract date. Resolution 2021-539, authorizing the purchase of motor vehicles from National Auto Fleet Group, Watsonville, CA in an aggregate amount not to exceed \$386,205.47, pursuant to a national cooperative pricing agreement with Sourcewell was revised to add vehicles for the Electric Utility. Resolution 2021-540, authorizing a contract awarded to a stat contract vendor, Axon Enterprise Inc., Scottsdale, AZ for the purchase of additional body worn cameras (BWC) in the amount not to exceed \$171,670.10 was added and then revised to amend the amount, title and additional language. Resolution 2021-541 authorizing the purchase of automated external defibrillators for the Fire Department and EMS from VE Ralph and Son Inc., Kearney, NJ in the amount not to exceed \$25,998.00 pursuant to a regional cooperative pricing agreement with Middlesex Regional Educational Services Commission (MRESC) cooperative pricing system was added. Resolution 2021-542, designating Oceanfirst Bank N.A. as an approved depository for Municipal funds for bond anticipation notes and appointing the Mayor, Chief Financial Officer, Business Administrator, Treasurer and Assistant Treasurer as signatories thereon was added.
