Councilman Franceschini reported that there are 888 positive COVID-19 cases and 7 deaths in Vineland for the month of December, so far. He stated the Omicron variant is very contagious and is now the dominant strain. He urged everyone to be smart at holiday gatherings.

Councilman Acosta noted the first confirmed Omicron variant death. It was a man in his 50s in Texas. He commended Vineland's first responders who had to respond to recent incidents. He encouraged everyone to be responsible, and if you drink alcoholic beverages, don't drive. He wished all a Merry Christmas and Happy New Year.

Councilman Vargas reported that P.A.L is discussing beginning a culinary program and another basketball program. A boxing exhibition bout is planned for April.

Dr. Arthur wished everyone a safe and healthy Christmas. She urged all to keep our first responders in our prayers. She also noted that no students will be present next week to lead the pledge of allegiance because of the Christmas break.

Solicitor Tonetta wished all a Merry Christmas.
