REGULAR MEETING TUESDAY, JANUARY 11, 2022 6:30 P.M.

The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Dr. Elizabeth A. Arthur.

The President led the Pledge of Allegiance.

The Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 15, 2021 by the City Clerk, in the following manner:

- 1. Posting written notice on the official bulletin board in the lobby of the City Hall;
- 2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City; and;
- 3. Filing written notice in the office of the City Clerk of the City of Vineland.

The President entertained a motion by Councilman Acosta, and seconded by Councilman Franceschini, that the 2021 minutes of the Pre-Conference and Regular Meeting of December 28; and the 2022 minutes of the Work Session of January 4, 2022 be approved as submitted.

The President asked if there was any discussion by Council members on this motion.

Councilman Franceschini introduced Meghan Spinelli, the new president of the Vineland Board of Education. Ms. Spinelli stated that she was looking forward to the Board of Education and City Council to be working together. She welcomed City Council members to visit all Vineland public schools.

The President invited Sharon Flaim, Director of Solid Waste, to the podium. Ms. Flaim explained the current status of trash-recycling collection. She explained that the City of Vineland does not collect trash or recyclables. That task is contracted to outside entities. Currently, the Atlantic County Utilities Authority (ACUA) is in a five-year contract that began in 2019. The contract calls for twice-a-week trash pickup and once-a-week recyclables pickup. Collection, especially over the past year, or so, has been sporadic. ACUA has not met its contractual obligations and the matter is in legal review to consider all options.

The President asked if there was anyone in the audience who wished to be heard at this time.

Steve Lewis commented that it is not right that City Council members have to bear the burden of complaints relating to trash and recycling collection. He urged concerned residents to call the ACUA directly. He questioned how the ACUA could expand service to Millville, when they can't handle Vineland. He said Vineland residents are paying for a service and they deserve to get the correct service.

Rick Dovey, President of the Atlantic County Utilities Authority. He introduced himself and two staff members who were also present in the audience. He said he was very sorry about the poor service. A severe labor shortage, due to the COVID-19 pandemic brought an unprecedented and unpredictable labor situation. The latest surge has negatively impacted their recruitment efforts, and it's the same in Vineland and in the municipalities served in Atlantic and Cape May counties. Each morning 25%-35% of the workforce calls out. He explained that ACUA is dedicated to do the job as scheduled. He assured City Council that ACUA has enough equipment, but it's the labor – CDL drivers and laborers – that strains the effort. The recent snow storms have also presented operational challenges. He explained that problems were minimal prior to the pandemic and explained that all haulers are having the same difficulties.

Councilman Spinelli commented that Vineland's issues seemed to appear when ACUA started their service in Millville. Mr. Dovey responded that they don't favor one town over another. Vineland has the challenge of twice-a-week pickup that does not exist in any of their other contracted towns, but it's the pandemic and labor shortages causing the problem.

Councilman Franceschini asked Mr. Dovey what ACUA can tell us about handling the Vineland contract the way it should be. Administrator Dickenson asked for a written plan to share with our constituents. Mr. Dovey responded that they can't do that. They just don't know about the labor issues. But they will try to create a plan.

President Arthur suggested identifying and prioritizing the areas that are behind schedule. Mr. Dovey explained that Ms. Flaim is consistently persistent to identify to the ACUA problem areas that need to be addressed. This concept of identifying and prioritizing areas seemed to be accepted by Mr. Dovey.

Councilman Acosta stated that he was sympathetic to the labor shortage in reference to the City's trash and recycling contract with the ACUA, but at the same time there are obligations not being met. We need to be sure that we don't pay for services we are not receiving.

Councilman Spinelli commented that the VDID meets next week. He stated that the City needs to explore ways to ween the VDID off their large dependence on UEZ funding. He also agreed with the posture of Councilman Acosta, while we are sympathetic to unforeseen labor shortages, we need to protect our taxpayers. He also noted that the Landis Theater is back with shows.

The President entertained a motion by Councilman Acosta, and seconded by Councilman Franceschini, to adjourn the meeting.
