REGULAR MEETING TUESDAY, JANUARY 25, 2022 6:30 P.M.

The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Dr. Elizabeth A. Arthur.

The President led the Pledge of Allegiance.

The President asked Associate Solicitor Benson to offer comments. Mr. Benson explained that City Council has no jurisdiction in an appeal or overturning a decision of the Zoning Board of Adjustment. He read an excerpt from an ordinance adopted in 2009 that dictates appeals of decisions rendered by the Zoning Board must be filed with Superior Court. Councilman Franceschini inquired if the ordinance can be amended. Mr. Benson responded that the ordinance can be amended, but it would not be valid for decisions rendered prior to such amendment.

The President asked if there was anyone in the audience who wished to be heard at this time.

Anthony Peretti, Jr. asked how it could be that the Zoning Board of Adjustment an override the wishes of City Council. He said it was not right, concluding that it was purely a money issue. He observed that City Council permitted cannabis in Industrial zones only, and this is now intruding on a residential area, with a school in close proximity.

Joanna Zaak also noted that such uses were to be in Industrial zones only. She was frustrated that the minutes from the January 19, 2022 Zoning Board of Adjustment meeting were not available online. Municipal Clerk Petrosky advised that, typically, minutes of any board or commission are not posted online until the minutes have been approved in draft form first by that board or commission. In this case, it was unlikely that minutes from last week would have been drafted, reviewed and approved in such a short period of time. Ms. Zaak also raised air quality and health issues associated with cannabis. She also was concerned about security cameras and a potential invasion of neighbors' privacy.

Steve Lewis questioned the Municipal Clerk, suggesting that if the minutes were not yet approved, the Zoning Board could change the outcome by amending the minutes. Clerk Petrosky commented that the minutes are a reflection of comments and action that actually took place and that merely changing the minutes is not a valid way to change the decision of the Zoning Board. He reiterated Associate Solicitor Benson's statement that the only outlet for appealing a decision of the Zoning Board would be filing an appeal with Superior Court.

Don Ross raised some questions he had about cannabis. He noted that he suffers from RSD and lung problems.
