The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Dr. Elizabeth A. Arthur.

The President led the Pledge of Allegiance.

The Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 13, 2022 by the City Clerk, in the following manner:

- 1. Posting written notice on the official bulletin board in the lobby of the City Hall;
- 2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City; and;
- 3. Filing written notice in the office of the City Clerk of the City of Vineland.

The Clerk read the following: Public Comment provides an opportunity for members of the public to inform the governing body about their views. The governing body prescribes to City Council's by-laws and the NJ Statutes on Open Public Meetings when engaging during public comment. As such, each individual shall have a 5 minute limit to comment; cannot yield time to another individual; may only approach the podium once during public comment for any one topic; vulgar/offensive language is prohibited; and City Council will not engage in dialogue with the public during this time. The governing body maintains model courtesy and respect and requires members of the public to do the same.

The President asked if there was anyone in the audience who wished to be heard.

Gary Hampton. He explained that he is a 43-year resident and he is seeking assistance with noise, alcohol consumption and marijuana smoking at South Vineland (Anthony Campanella) Park. He stated that the police have not been responsive to his requests and has even experienced the police dispatcher hanging up on him. He alleged one-day permits have been issued, and he knows alcoholic beverages are not permitted in public parks. He suggested the installation of cameras to monitor the activities. Administrator Dickenson responded that this is the first time he is hearing of such a problem and that he will discuss it with the police.

Edward Roth. He reiterated his position that he favors the improvement of the former Avalon Tile & Carpet building by Gary Singh as an entertainment, food, and liquor facility. He reported a verbal agreement reached with Mr. Singh for weekday closings at 11 p.m. and midnight on weekends, including "last call" a half-hour prior to closing. His main point of concern is noise that may create a problem for his guests staying at the Holiday Inn Express, especially after they have had a few drinks and go into the parking lot.
