The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Dr. Elizabeth A. Arthur.

The President led the Pledge of Allegiance.

The Clerk noted that representatives of the Vineland Police Department were in attendance for a presentation concerning accreditation of the police department.

Harry Delgado of the New Jersey Association of Chiefs of Police accreditation program explained that the Vineland Police Department has achieved its third accreditation, which is very rare. This is a significant professional achievement, with multiple proofs of compliance reviewed. He presented a framed certificate to Chief Pedro Casiano, Deputy Chief Steven Triantos, and Special Law Enforcement Officer Tony Mertis.

Chief Casiano explained that the police department is part of the community, and they take pride in the recognition accreditation brings. Council members and all those present applauded the recognition.

The President welcomed Miss Tri-City, Madison Manno. Ms. Manno explained her platform, which is awareness for genetic disease. She noted both her brother and she share a genetic issue. President Arthur thanked her for appearing tonight and Council members applauded her efforts.

The Clerk read the following: Public Comment provides an opportunity for members of the public to inform the governing body about their views. The governing body prescribes to City Council's by-laws and the NJ Statutes on Open Public Meetings when engaging during public comment. As such, each individual shall have a 5 minute limit to comment; cannot yield time to another individual; may only approach the podium once during public comment for any one topic; vulgar/offensive language is prohibited; and City Council will not engage in dialogue with the public during this time. The governing body maintains model courtesy and respect and requires members of the public to do the same.

Thomas Price, Vineland, referenced the petition he delivered earlier today to the Clerk's office and conveyed the concern of over 100 families who signed the petition seeking assistance from the Vineland Police Department in better monitoring the traffic laws and regulations in the neighborhood of Spring Road and Magnolia Road.

Gary Hampton, Vineland, reiterated his concerns and pleas for assistance about the loud music/noise coming from parties being conducted in the evenings at Campanella Park. He stated no help has come from the police, despite repeated calls. He invited members of the governing body to visit his house to witness the noise firsthand. He questioned why the park can't be closed at 6 p.m. President Arthur assured him that she will be in contact with him.

Sheena Santiago, City events coordinator, offered a brief summary of upcoming events, including the final movie of the season; the wine and chocolate competition on October 8; the Columbus Day ceremony on October 9; the dedication of Dr. Martin L. King, Jr. Way on October 11; the annual Christmas Tree lighting on December 1; and the Olde Fashioned Christmas activities.
