The President led the Pledge of Allegiance.

The President asked if anyone from the public would like to comment.

There being no one to be heard, the Clerk reviewed the agenda.

The Clerk reminded everyone that no Council meeting is scheduled for Tuesday, October 29, since it is the fifth Tuesday of the month.

Councilman Franceschini commented on the recent number of ribbon cuttings, specifically noting the Barbera's new ice cream shop opening. He also commented that the Columbus Day ceremony was nice.

Councilman Vargas added that elected city officials should be afforded seating at special ceremonies.

Councilman Spinelli commented that the retirement dinner for Fire Chief Luigi Tramontana was a nice event. He stated the Columbus Day Italian flag raising was nice, and not drawn out. He noted that some of the set up and hors d'oeuvres could use refinement, and suggested that he was willing to help in the future, and other Council members may also be interested in helping.
