There being no one to be heard, the Clerk reviewed the changes to the agenda since last week's work session. A revised version of Resolution 2024-485, exercising the (2) year contract extension to contract C22-0148, issued to J. Bishop Construction, Inc., Millville, NJ for snow removal services and associated equipment, was provided to incorporate several corrections in the body. Resolution 2024-498, authorizing the execution of a change order no. 5 to a professional services agreement by and between New Road Construction Management, Co., Cherry Hill, NJ and the City of Vineland construction management services for \$49,800.00 for the new fire station and demolition of existing building on the site, was added. Resolution 2024-499, supporting the site specific water quality management plan amendment submitted to the NJ DEP for property located at 1477 Panther Road, Block 5301, Lot 11, was added. Resolution 2024-500, authorizing a professional services contract with the law firm of Keller and Heckman LLP for legal services related to broadband services, was added. Resolution 2024-501, authorizing participation in the Pedals for Progress Program through the Rotary Club of Vineland, was added. Resolution 2024-502, authorizing the execution of a grant application and grant agreement for grant funding from the NJ UEZ Authority in the amount not to exceed \$340,710.00 for the Vineland Urban Enterprise Zone 2025 commercial corridor cleaning and maintenance project year 3, was added.
