Steve Lewis asked about the Broadband Utility Ordinance and its costs. He mentioned the County how he heard it was going to cost millions of dollars to build and maintain. He then questioned validity of Jersey First who was in opposition to the Ordinance. The City believes they are a lobbyist for Comcast.

Finally, he requested that a new use agreement relating to Gonzalez Park be prepared, if the current one cannot be located by the end of March.

Councilman Spinelli stated that Vineland is hosting a Karaoke night at the Greenview Inn at Eastlyn Golf Course on Friday March 15, 2024. It is open and free for all. He also mentioned VDID met and passed new bylaws. They also approved job descriptions and they are looking for an administrative assistant.

President Dr. Arthur mentioned she participated in Read Across America recently and saw the Mayor leaving as she was walking in to Petway School. She mentioned to consider contributing one's time to the cause as it's very rewarding and eventful for the children.
