Dan Pennino from Vineland, NJ stated he believe this was the exact same thing and meeting that happened at the College. He stated they were going to charge 45 million dollars to Cumberland County and to maintain that Broadband it was going to cost taxpayers 12 million dollars a year. From the research he's done, other municipalities tried it and it ended up failing. He had questions about "dark wires" that are those that are unused in the fiber and picked up by another company and used. He is opposed to this venture because it never made it in 99% elsewhere and the municipalities were left with the bill. He believes this is a huge burden on Vineland. The economy is not solvent and people do not have leftover spendable cash.

Dan Pennino's wife also spoke mentioning people were misled to think this would help the general public. She believes it will not. She argued the City cannot afford higher taxes. She asked all of Council to not even consider Broadband. She said many projects started were never completed and as a result, the failed projects left holes. She closed with, "Vineland cannot afford any more holes."

Steve Lewis from Vineland, NJ received spam calls from Jersey First and left a voice message inferring this project would cost 10's of millions of dollars but left no indication of how things were going to be. He commented that it's difficult to side whether good or bad with something until one knows how much something will actually costs. He asked why wasn't a representative of Jersey First here to provide their case? They lobbied and called everyone in opposition but they will not show up. He mentioned that people should come and ask Council questions to find out before they decide on numerous issues. He was taught, follow the money. He would like to know the real costs, who works for who and how will it benefit the citizens before he decides either way. He begged people to come to a work session to discuss with Council.

Steve Solof from Vineland NJ, piggy-backed off Mr. Lewis in that he, too, received calls and flyers from Jersey First about the Broadband and made the same assumption that it was the same type of project but contacted Mayor Fanucci who stated Vineland's project is very different from that proposed to Cumberland County. He also stated the Mayor said the 60 million dollar figure floated was not even close to the actual cost. Solof stated the Mayor stated it would be minimal cost because the City of Vineland already owns its own utility poles, and fiber and much of it is already in place. Solof mentioned this is an infrastructure upgrade to better the future. He too believed people should ask questions before making decisions which was why he contacted the Mayor.
