The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Dr. Elizabeth A. Arthur.

The President asked if anyone from the public would like to comment.

There being no one to be heard, the Clerk reviewed the agenda changes and additions. Ordinance 2024-50, an ordinance in accordance with the provisions of N.J.S.A. 40A:12-4 and N.J.S.A. 40A:12-5 approving easement agreements accepting grants of easements for the purpose of constructing drainage easements, was added. The resolution recognizing Rafael Lopez upon retiring from public service effective August 1, 2024, was re-assigned to be number 2024-363.

Councilman Franceschini asked about the status of PPE for any upcoming pandemic. Director Franchetta responded that the inventory is monitored and that a report will be forthcoming. Councilman Franceschini also reminded everyone that that their CPR certification expires in September. A date for recertification training will be arranged.

Councilman Vargas reported that new plaques have been ordered for a playground and the dog park. North Vineland Little League has a new president. The Soccer Association requested new lighting for some fields and the costs and logistics are being explored. The issue of fingerprinting youth league coaches is also under scrutiny. IDs have been discussed. It was noted that part of the Recreation Director's job is to ensure compliance with fingerprinting and background investigation of youth league coaches.
