The President asked if anyone from the public would like to comment.

Steve Lewis read an article about Dr. Arthur's involvement with an educational foundation and congratulated her. He also expressed congratulations to retiring Clerk Keith Petrosky.

There being no one further to be heard, the Clerk reviewed the changes to the agenda since last week's work session. Ordinance No. 2025-18, an ordinance to amend and supplement Ordinance No. 8, which established the classification and compensation plans for the City of Vineland (Vineland Superior Officers Association {the VSOA}), was added. Resolution 2025-111, approving agreement with the Vineland Superior Officers Association from January 1, 2025 through December 31, 2027, was added. Resolution 2025-112 commending the American Red Cross and designating March 2025 as 'American Red Cross Month,' was added.

Councilmember Arthur did note that March is Red Cross month.

Councilmember Vargas reported that there was a PAL board meeting and the new director introduced a new boxing coach.

President Spinelli stated that the PAL attorney is drafting a job description for the executive director. He noted that Public Safety Director Alicea has volunteered to assist with PAL. The PAL board will develop a 5-year plan and the goal is to make it a vibrant and effective program for kids. There was a meeting with Cumberland County about technology. The convention center at the former Amish Market should be ready in the Fall, as events are already being booked. The Olde Fashioned Christmas event will be reformatted to be an indoor event using the new convention center.

Councilmember English related a program at Delsea Regional High School for vocational programs, including encouraging police officer recruits.
